Champions for Wildlife delivers Wild for Art programs that connect elementary-aged students to native North Carolina wildlife through a combination of science-based learning and hands-on art. Programs are delivered directly in classrooms and community settings, removing barriers to access and supporting diverse learning styles. Each program includes a standards-aligned wildlife lesson followed by a guided art activity that helps students creatively express what they learned.

During the tax year, Champions for Wildlife:

- Delivered 310 Wild for Art programs
- Reached 4,875 students across Western North Carolina
- Served primarily Title I and rural schools

In addition to in-school programming, Champions for Wildlife partnered with schools and community organizations to deliver after-school and expanded learning programs. These programs provide additional time for deeper engagement, creativity, and exploration of wildlife through art, particularly for students with limited access to enrichment opportunities.

During the tax year, Champions for Wildlife:

- Delivered programs in after-school and community-based settings
- Reached students across multiple grade levels and school systems
- Expanded access to wildlife education beyond the traditional classroom
- Strengthened partnerships with schools and local organizations

Champions for Wildlife continued to expand access to wildlife education through the development of digital and teacher-supported resources. These tools are designed to extend learning beyond a single program experience and provide educators and families with accessible ways to reinforce wildlife learning through art.

During the tax year, Champions for Wildlife:

- Began development of the Kids Corner, a digital hub for wildlife art activities and resources
- Created tools to help teachers integrate wildlife learning into their classrooms
- Extended program impact beyond direct instruction through accessible, creative resources
